Each League Member must complete the Player Registration section of this form, sign the Release of Liability, and pay annual League Dues before s/he shall be considered a member in good standing in the League. Individuals who do not sign the Player Registration and Release of Liability will not be eligible to participate in the Rose City Softball Association ("RCSA" and "League") for the 2009 Regular Season.

1: I, the undersigned, acknowledge the **Mission of the RCSA** as stated (in part below) in the RCSA By-Laws:

"... to create and establish an organized non-profit amateur athletic association, whose primary focus is on slow-pitch softball, for all persons regardless of age, race, creed, religion, gender, national origin, sexual orientation or athletic experience or ability, with special emphasis on the participation of the members of the gay and lesbian communities;"

And do hereby affirm that while attending any sanctioned RCSA activity, I will honor said mission and abide by RCSA By Laws, Rules, Code of Conduct, Casual Profanity Policy and Substance Abuse Policy.

- 2: **Release** – I hereby release, in their individual and representative capacities ("Release Party" and "Released Parties"), (i) the RCSA and its sponsors, agents, players, and officials, and (ii) the RCSA Board of Directors (individually and as a whole), from any and all claims, losses, liabilities, damages (including without limitation any damages to property, bodily injury or death), costs and expenses of any kind whatsoever, whether existing nor or occurring in the future, arising from my playing, participating in or attending any RCSA practice, game, activity or event, or any negligence, error, action, or omissions to act by any Released Party (collectively referred to as ("Claims")).
- 3: **Hold Harmless** – I hereby indemnify and hold harmless the Released Parties from and against any Claims.
- 4: **Personal Insurance** – I am fully aware that the RCSA carries no medical insurance for any participant, and that I am solely responsible for securing my own insurance, and that my team is responsible for securing its own insurance.
- 5: **Rules of Play** – I have been provided with access to a copy of the RCSA Rules, and am responsible for familiarizing myself with the contents thereof, located at www.rcsaopen.org or www.rcsawomen.org.
- 6: **Assumption of Risk** – I assume all risks involved in my participation in the League, and I recognize that I am solely responsible for my decision to participate in any game in the League, and that the above Release stated in Section 2 above includes, but is not limited to, a release for (i) maintenance or condition of the playing area, (ii) for the condition of the appurtenances thereto, and (iii) for equipment that may be supplied by the RCSA.
- 7: **Sports Skills** – I am familiar with the skill required to participate in the League conducted by the RCSA, and that the above stated Release in Section 2 includes, but is not limited to, a release for failure of RCSA to provide classes and for the technical instruction thereof.
- 8: During RCSA events, we may take photographs and other media of members for use in promoting the RCSA. This media may be posted on our web site, advertisements, or other league publications.
- 9: The RCSA does not distribute the names, addresses, or telephone numbers of its members to any parties outside of the Rose City Softball Association, except as required by NAGAAA, ASANA and ASA Softball Associations.
